Annual dress down day per student: **\$10** (Paid in September)

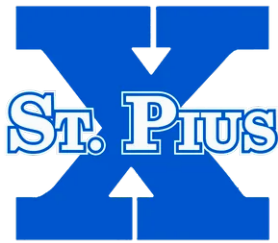
These funds are applied to the current 8th grade's Washington D.C. trip. 10 dress down days are scheduled throughout the year.

## TUITION ASSISTANCE

## TUITION PAYMENTS

FACTS Tuition Management, a third-party service, is the billing agent for all tuition payments. All families must create a FACTS account. Enrolling in a FACTS tuition payment plan allows you to select a payment option that best suits your financial needs. Automatic bank draft and credit card\* payment methods are offered. The plans listed below are offered by St. Pius X School:

Payment Plan Options	One Time Payment Plan Fee (Charged by FACTS)
<b>Annual</b> 1 payment made prior July 1	\$20
<b>Semi-Annual</b> 2 payments made in July and January	\$20
<b>Monthly</b> 10 payments made July - April	\$50

\*Payments made by credit card are charged an extra processing fee by FACTS.

## TUITION POLICY

There will be a \$30.00 fee assessed by FACTS for returned payments.

The consequence of non-payment will result in the notification of the pending removal date of your child(ren).

July and August payments are due before school starts. If St. Pius X has not received your tuition payments, your child's seat will automatically be assigned to the next student on the waiting list. Tuition payments made for students who withdraw after August 15 will not be refunded.

Enrollment for the following school year will not be accepted if tuition and fees for the current school year are delinquent. SPX fees include, but are not limited to: Enrollment, Technology, Field Trips, Latchkey, etc.

School records will not be forwarded until all financial obligations are current.
